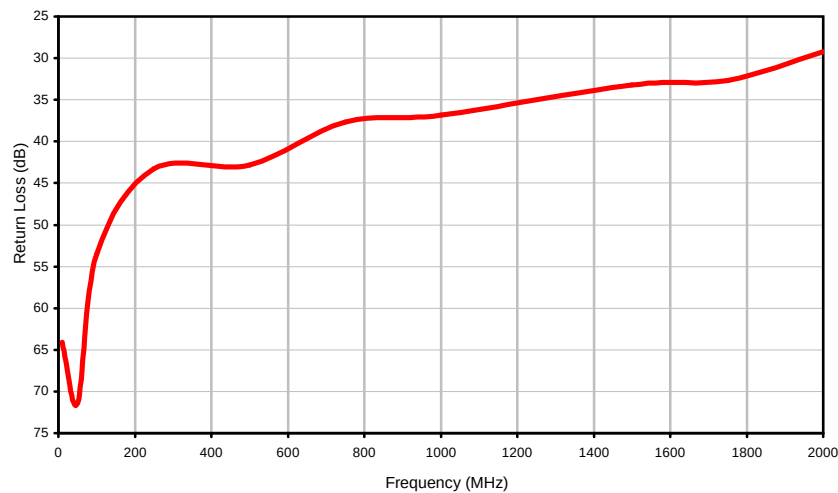


Typical Performance Curves

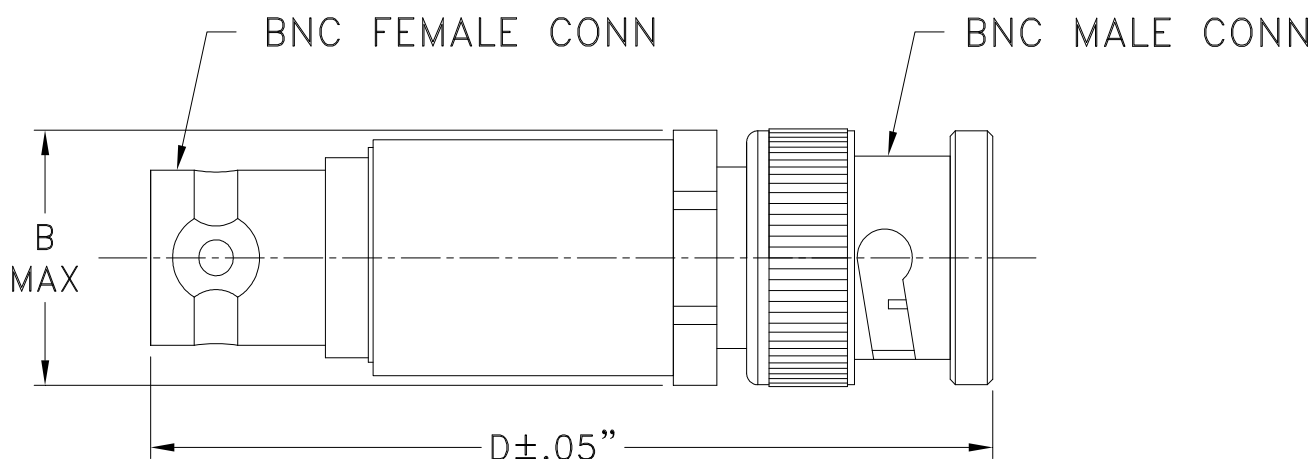
