



PCB Land Pattern









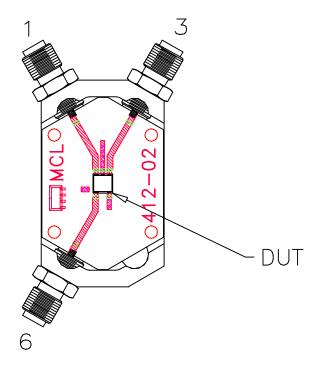

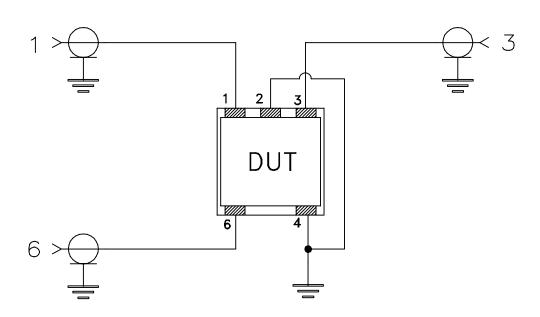
