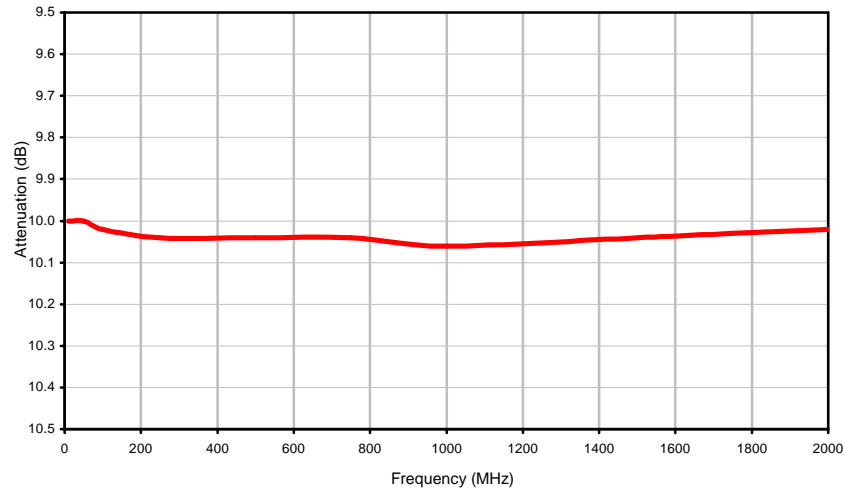

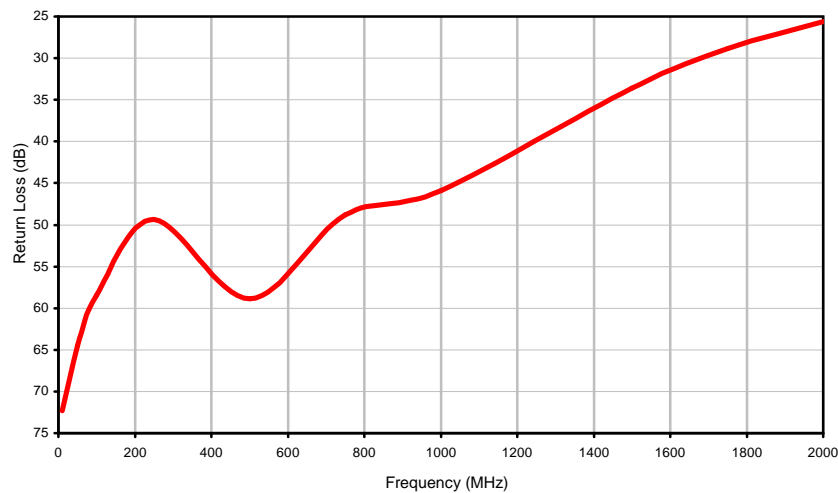


Typical Performance Curves

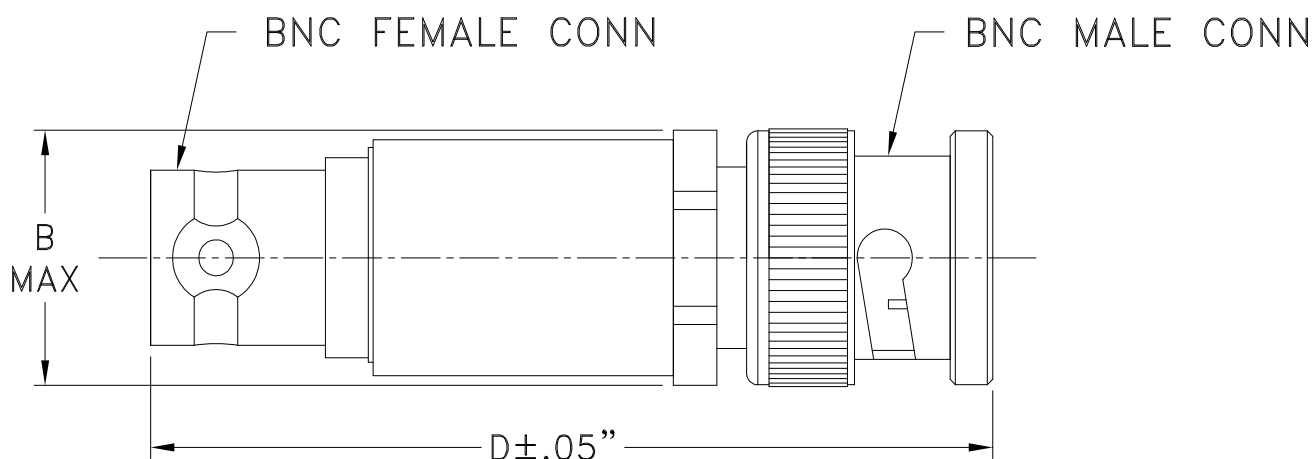
