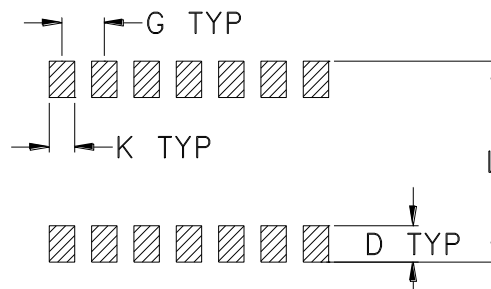

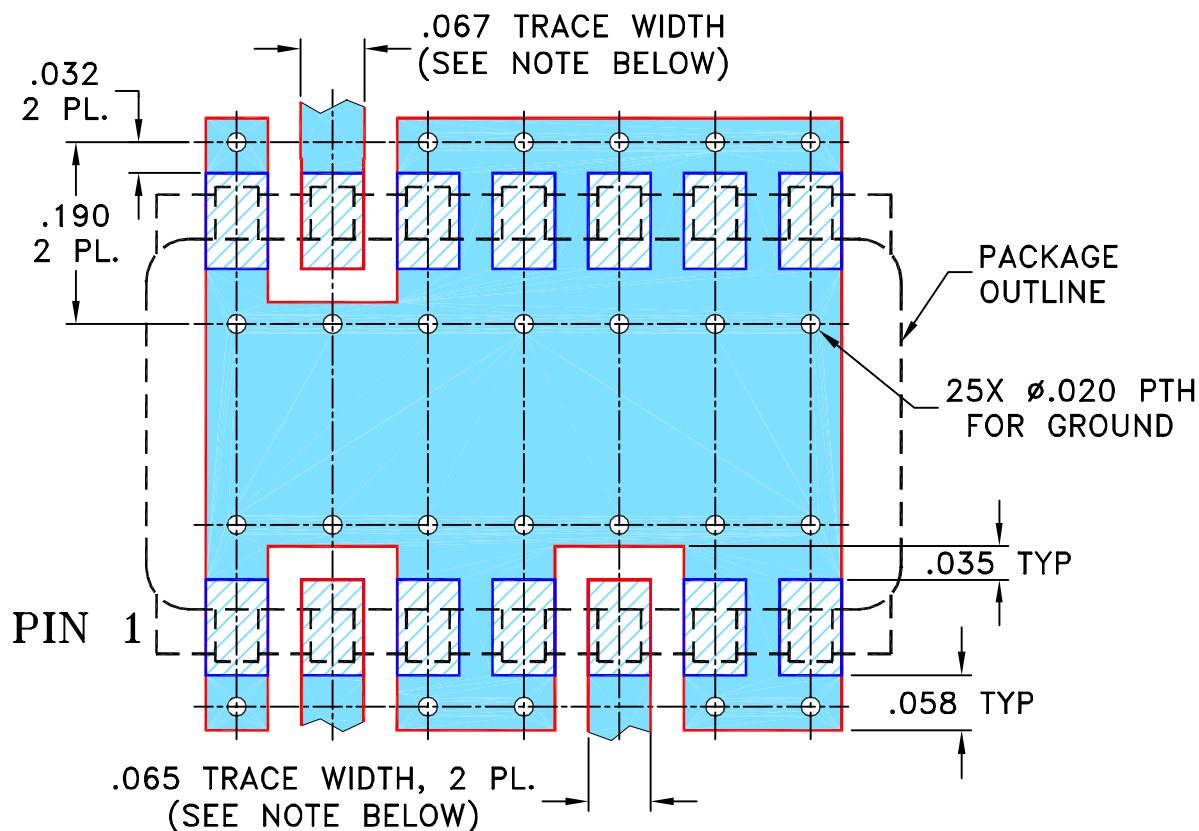

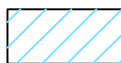
SUGGESTED MOUNTING CONFIGURATION FOR BK377 CASE STYLE, "jc" PIN CONNECTION

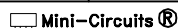

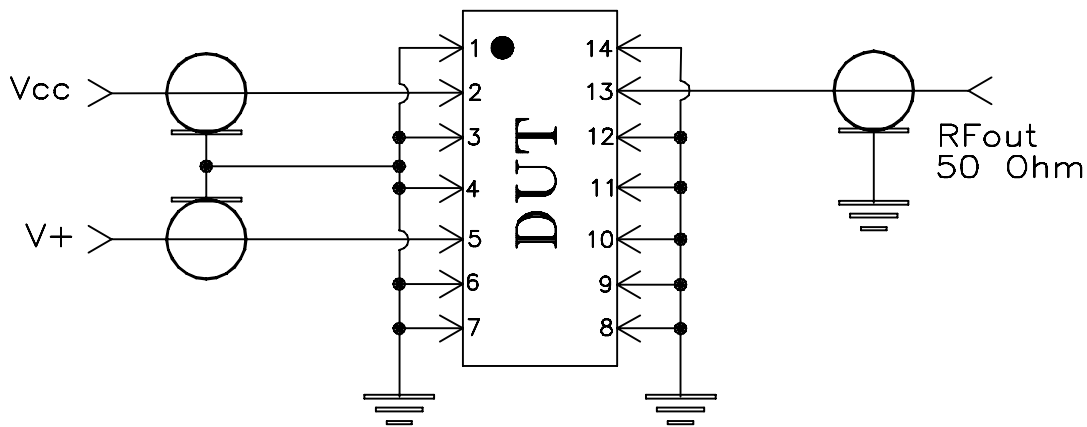

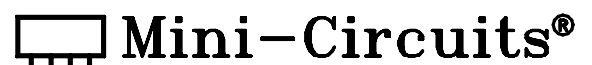
