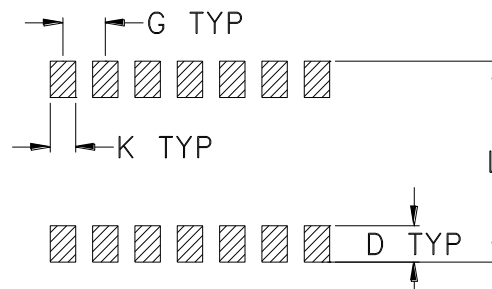

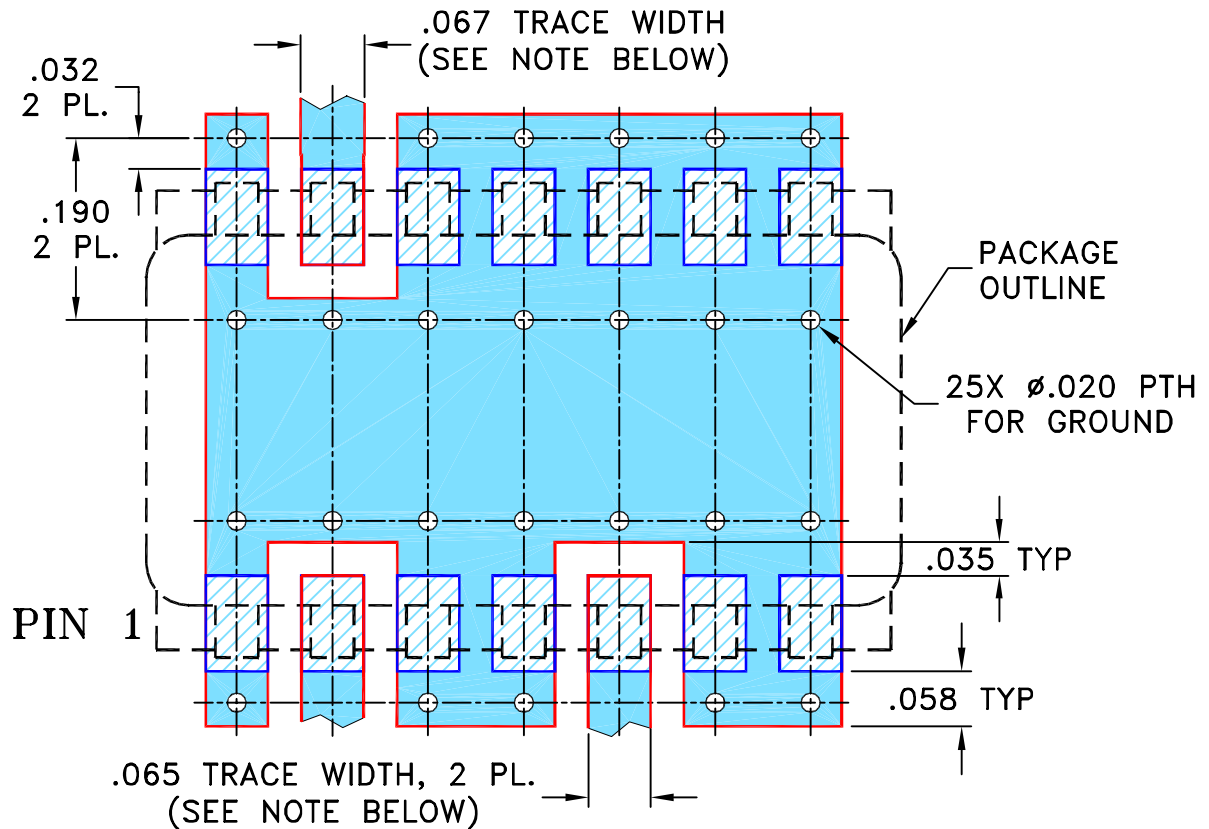

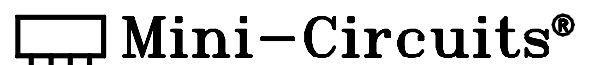
Evaluation Board and Circuit
