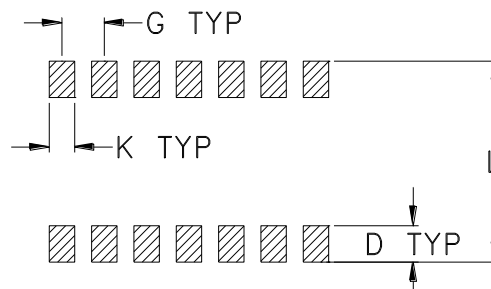
Typical Performance Curves

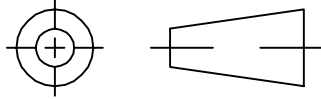

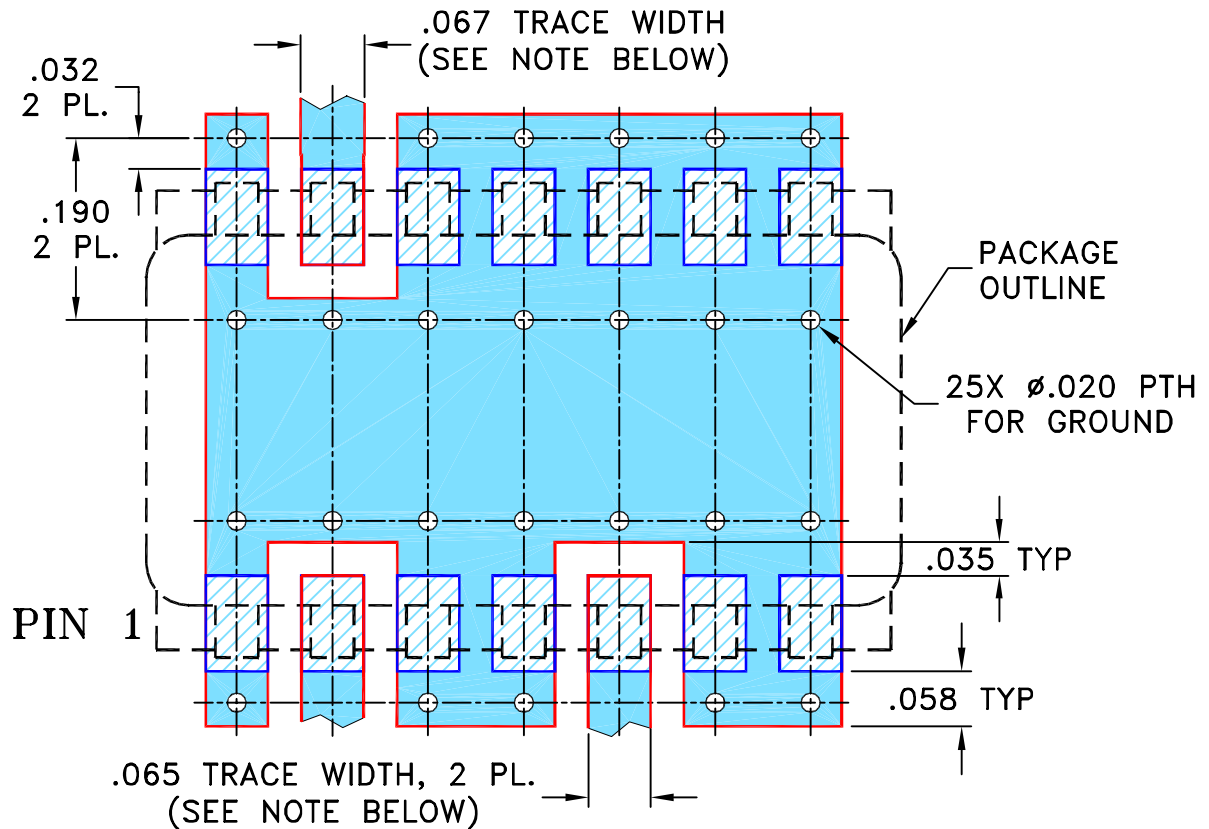

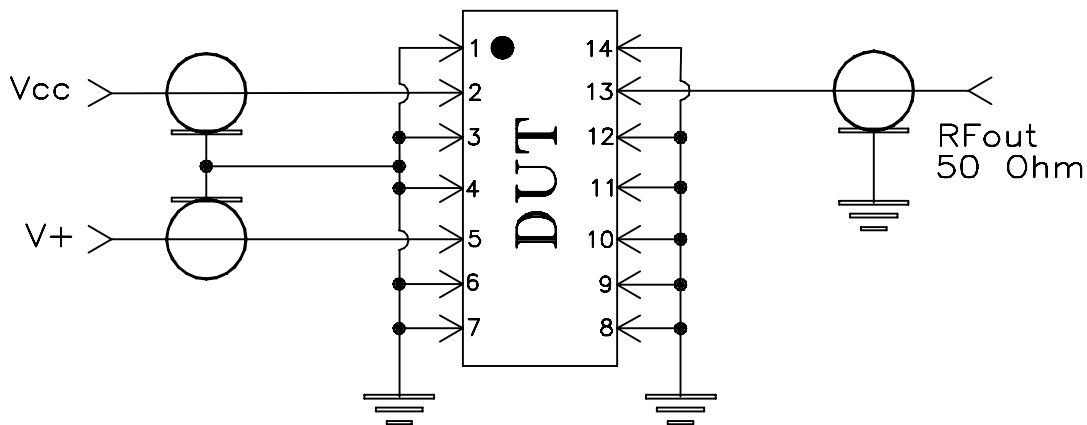
