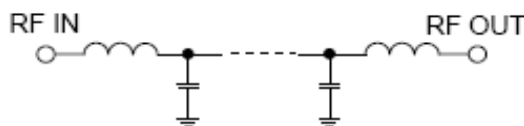

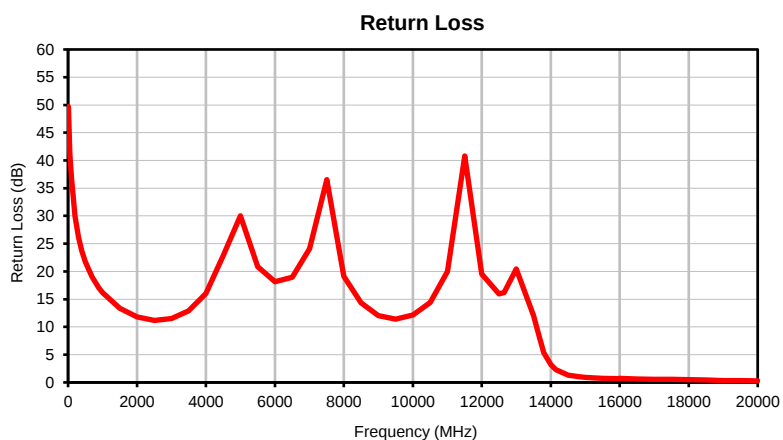
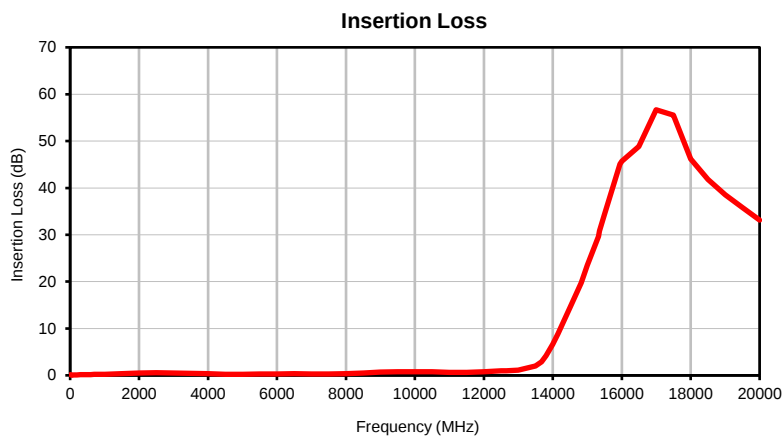

DEVICE ORIENTATION IN T&R

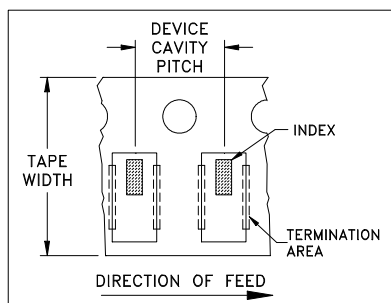

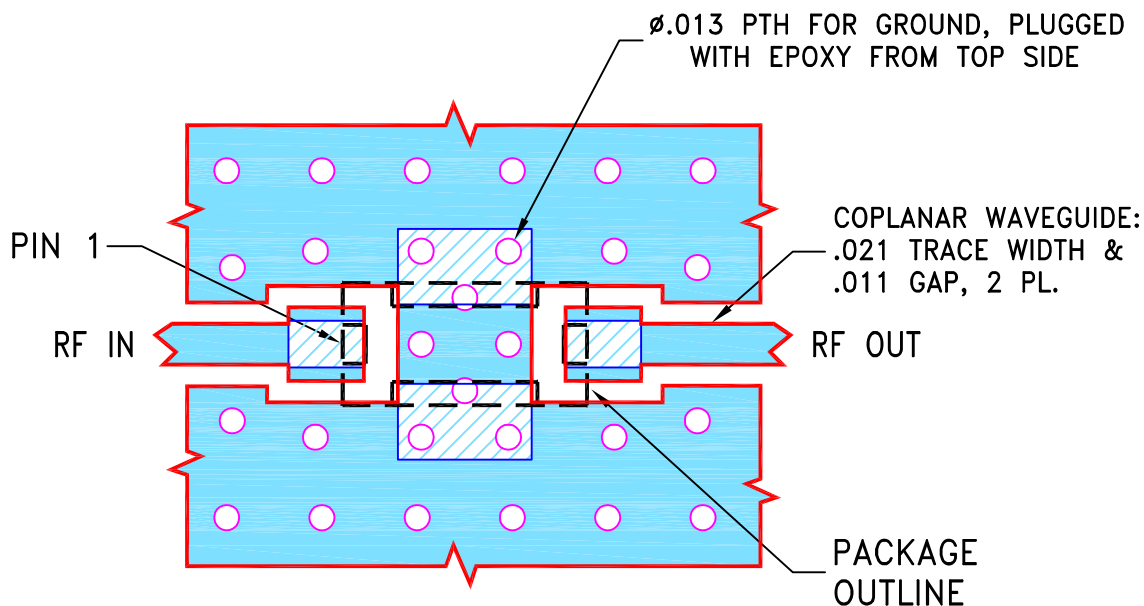
THIRD ANGLE PROJECTION

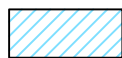

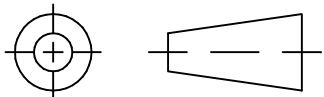

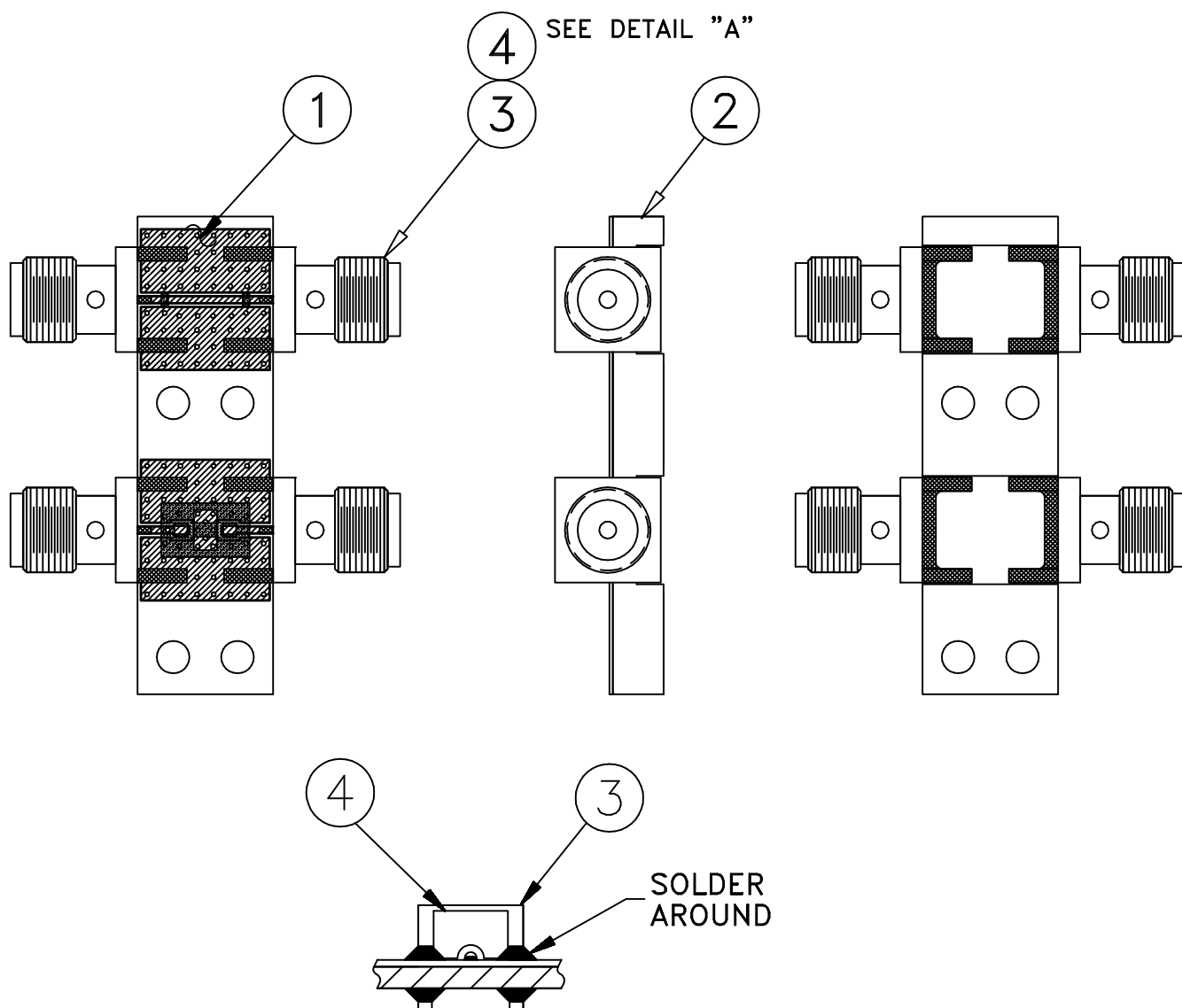
