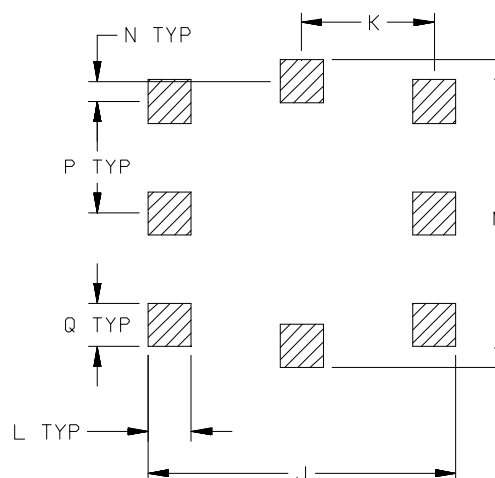

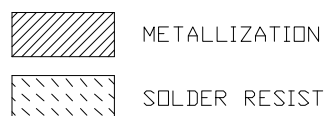
Outline Dimensions

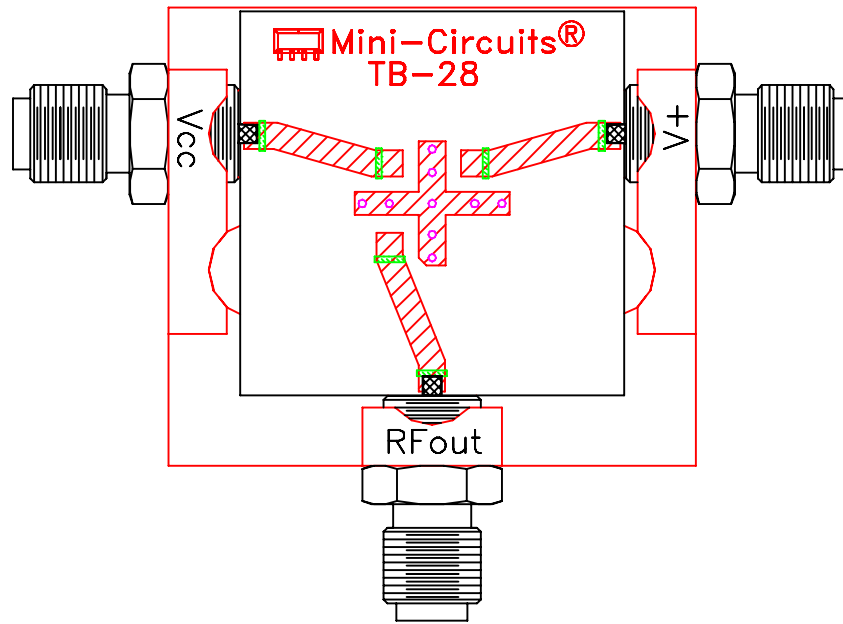

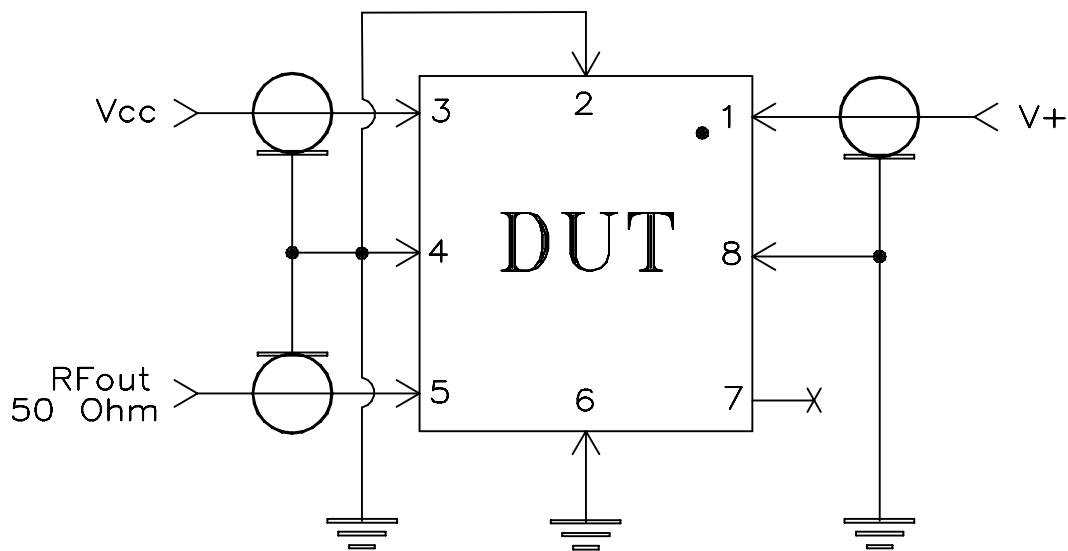
