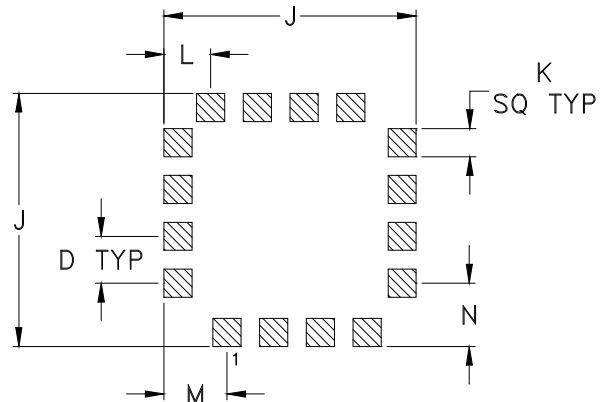
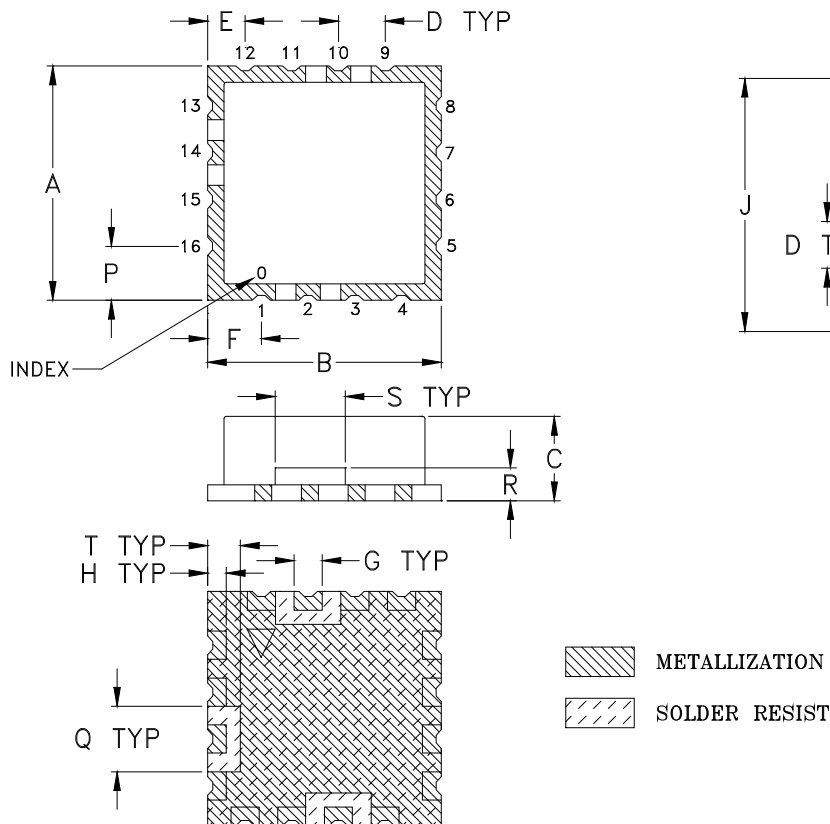
Typical Performance Curves
