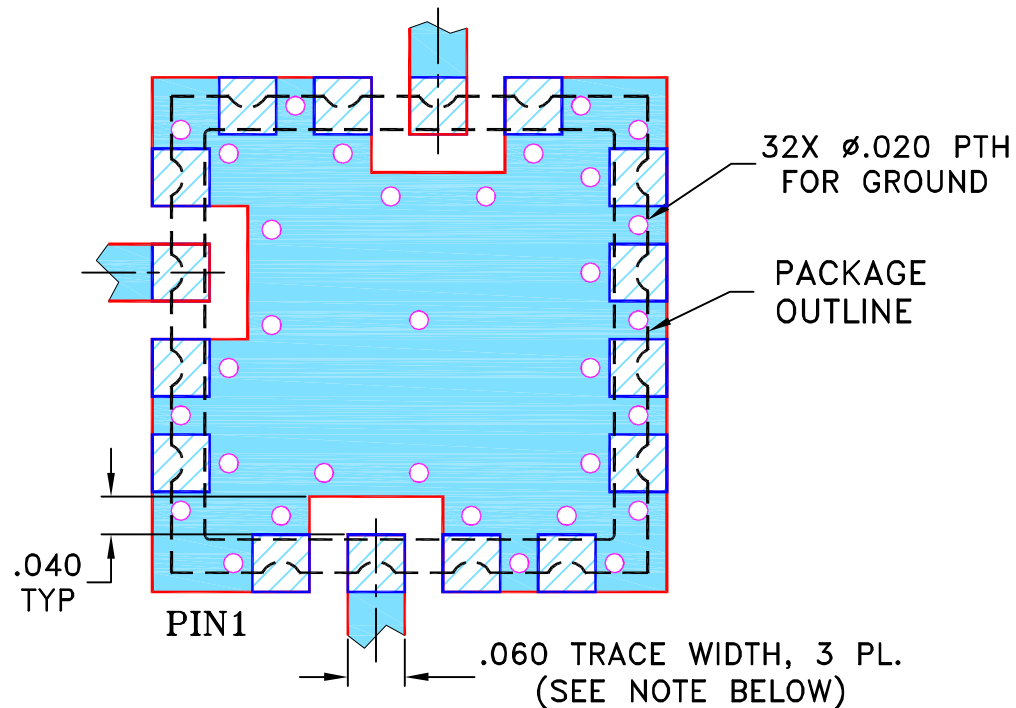
THIRD ANGLE PROJECTION

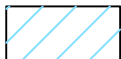

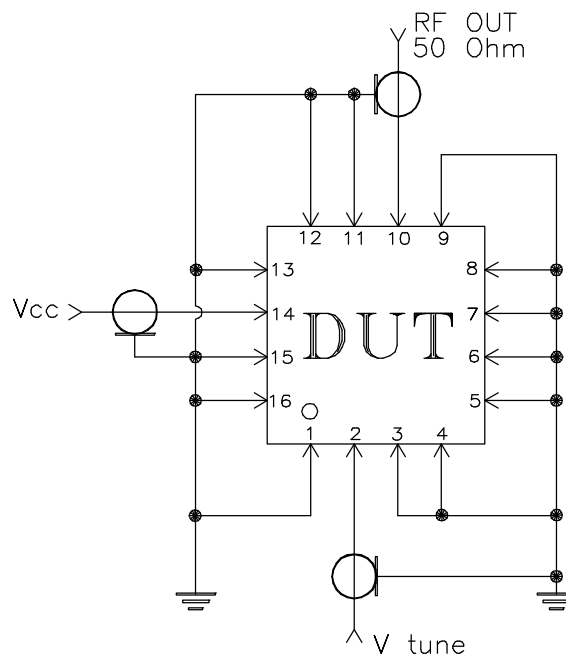
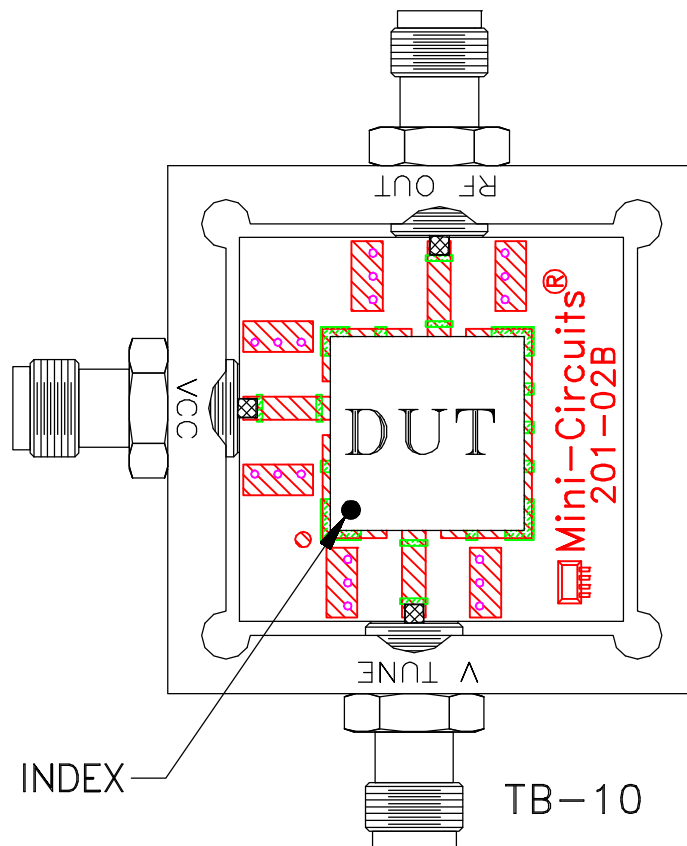
