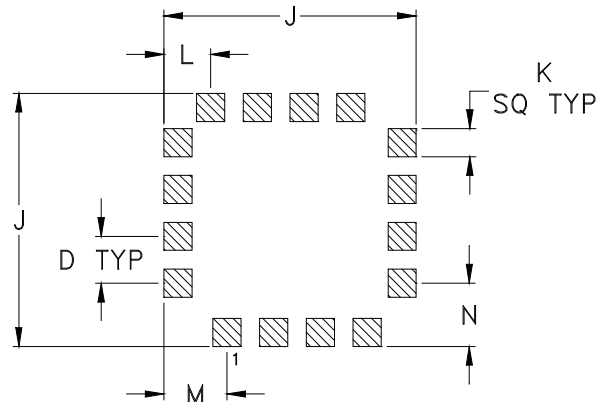
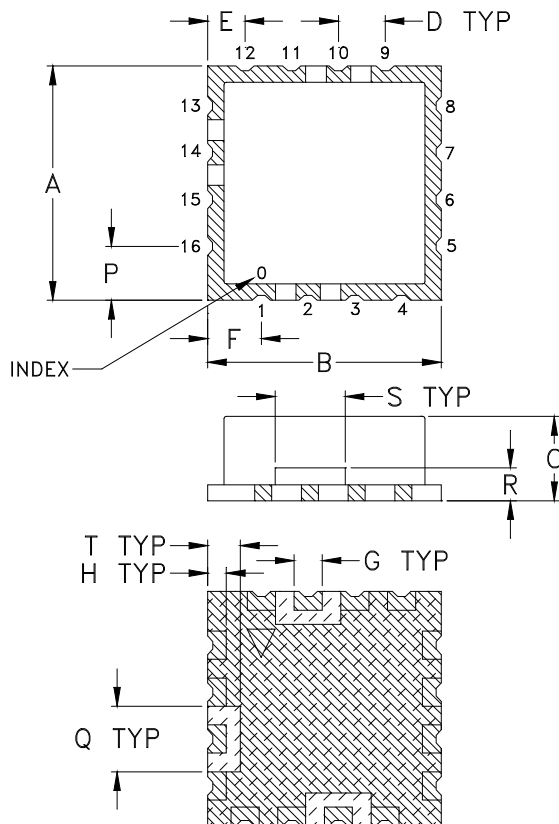
Typical Performance Curves

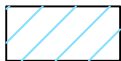
