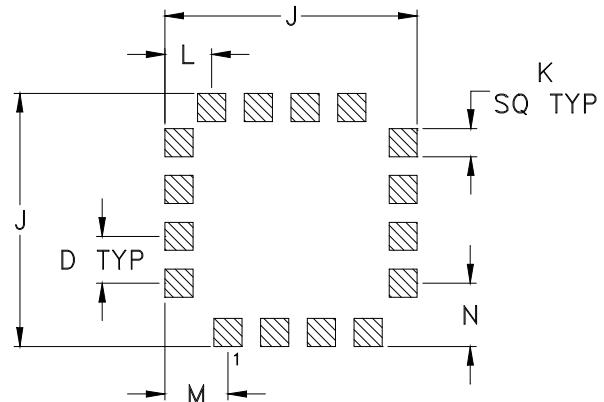
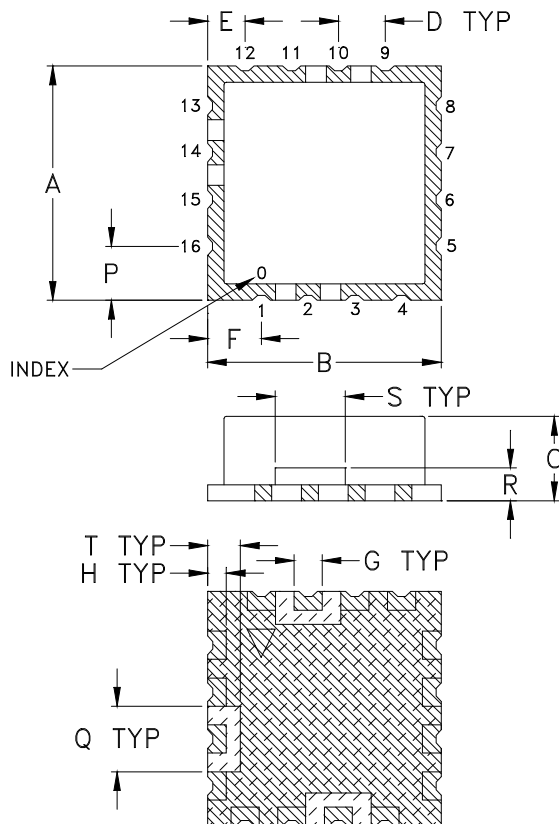
Typical Performance Curves

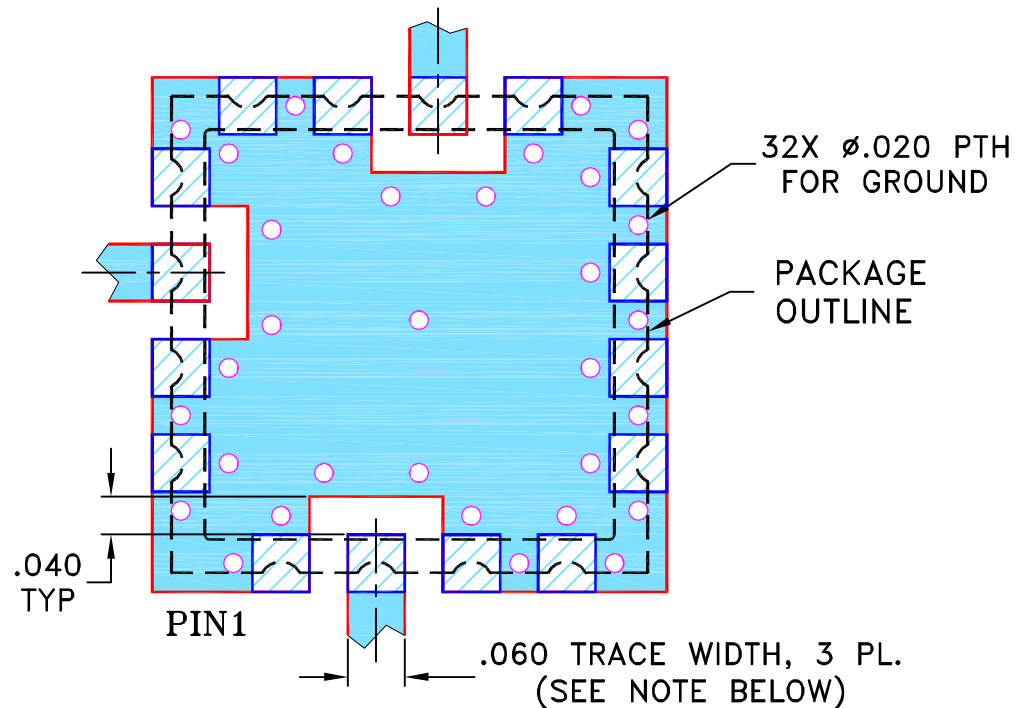

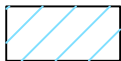

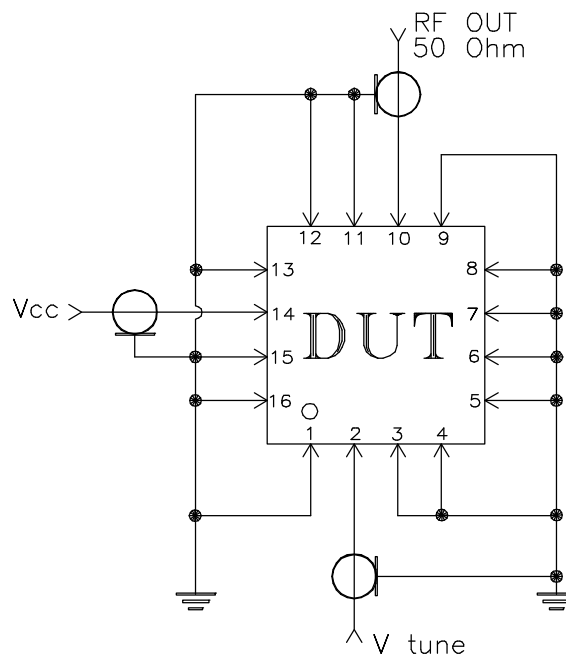
