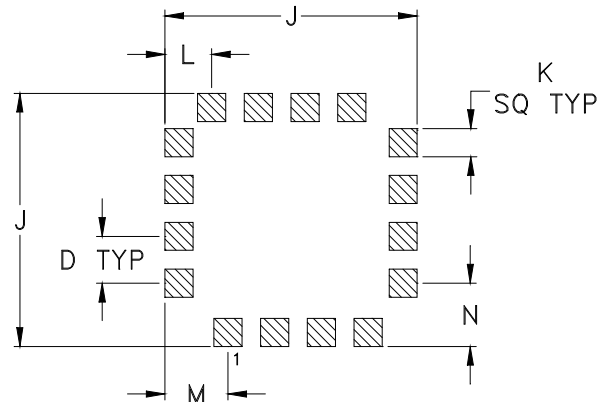
Typical Performance Curves
