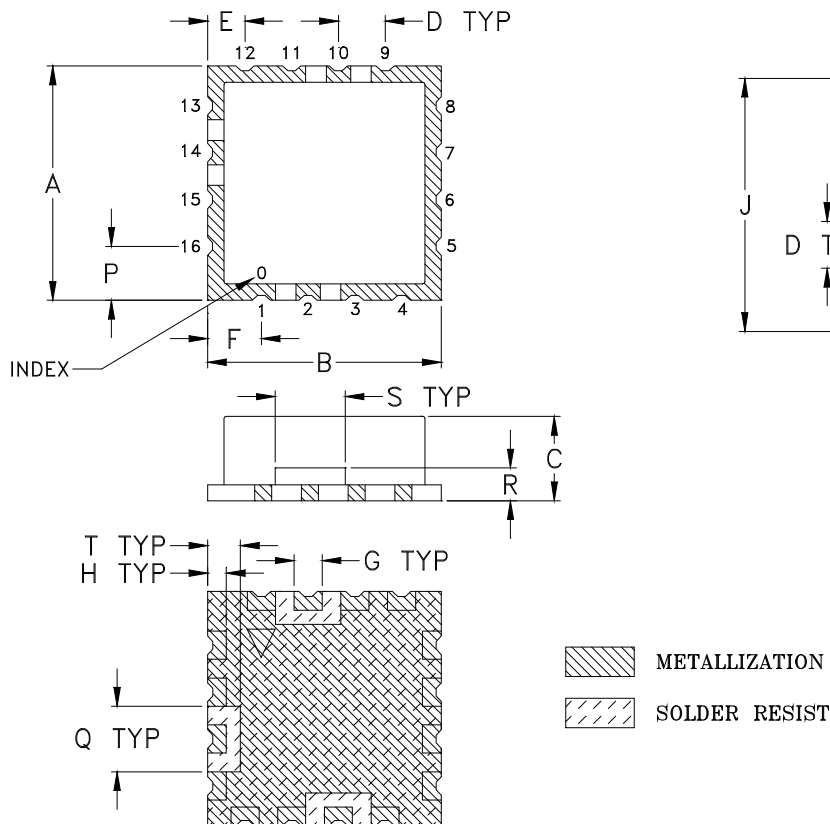
Typical Performance Curves

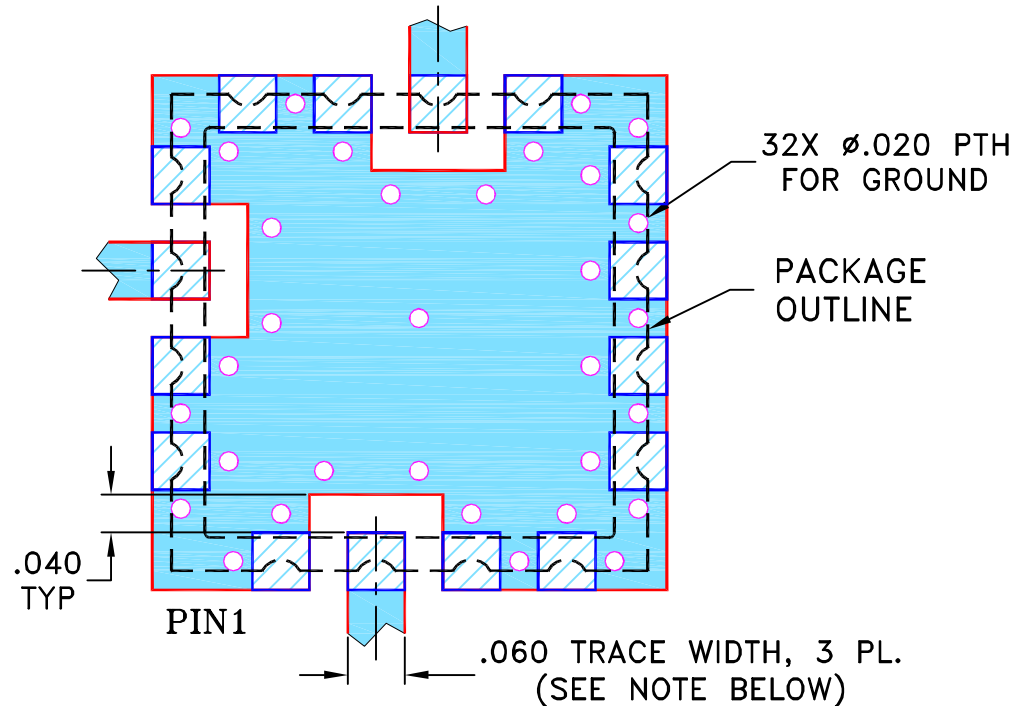

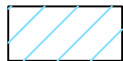

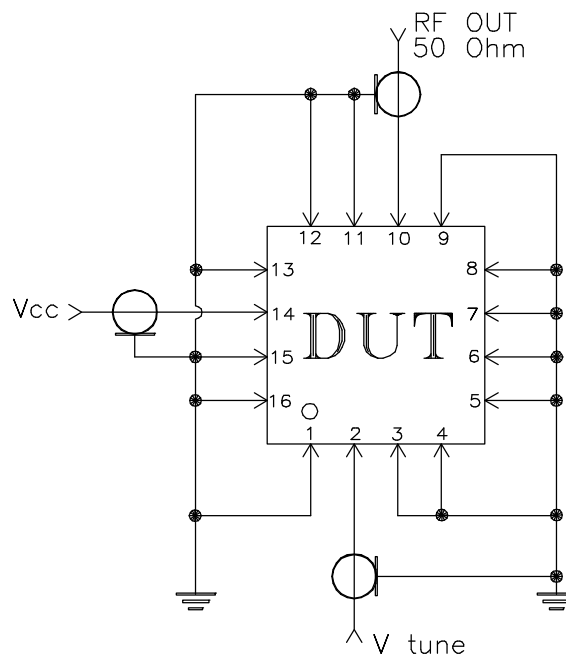

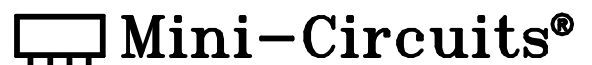
