Typical Performance Curves

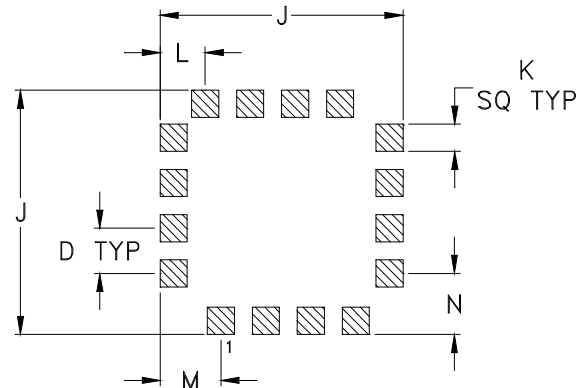
