Typical Performance Curves

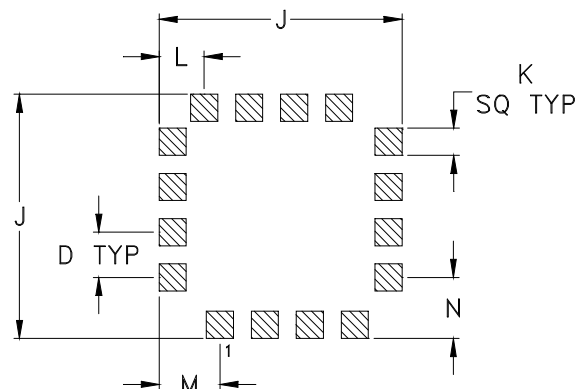

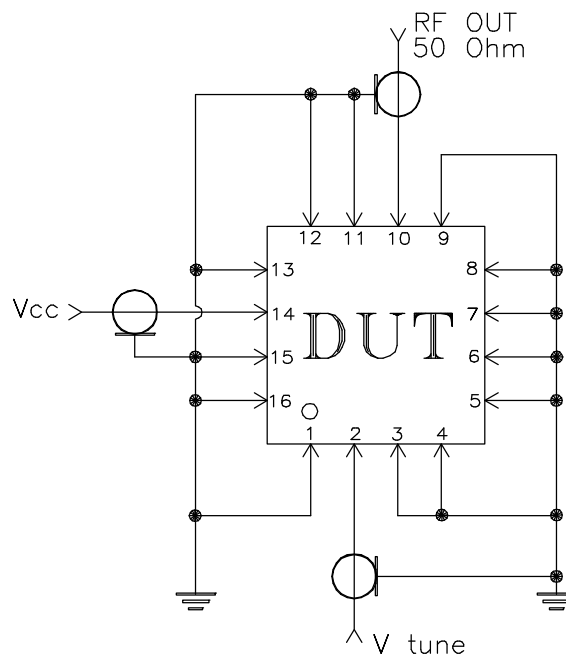

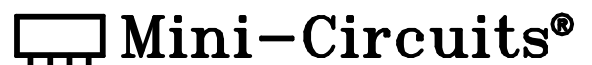
