Typical Performance Curves

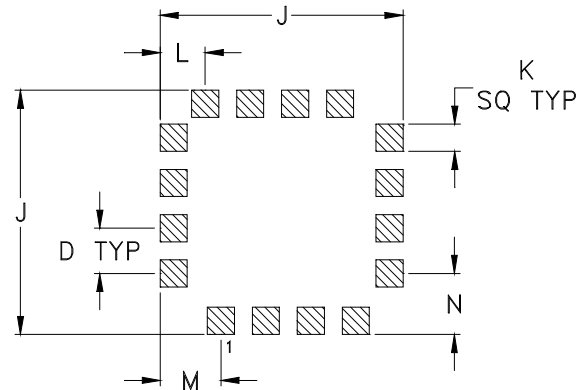
