Typical Performance Curves

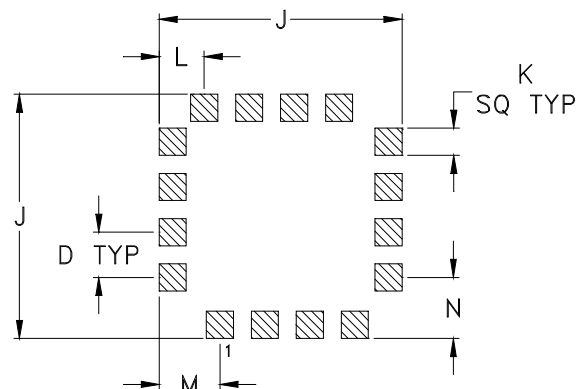
