Typical Performance Curves

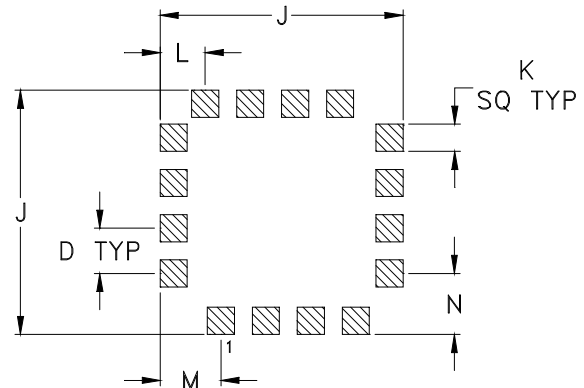

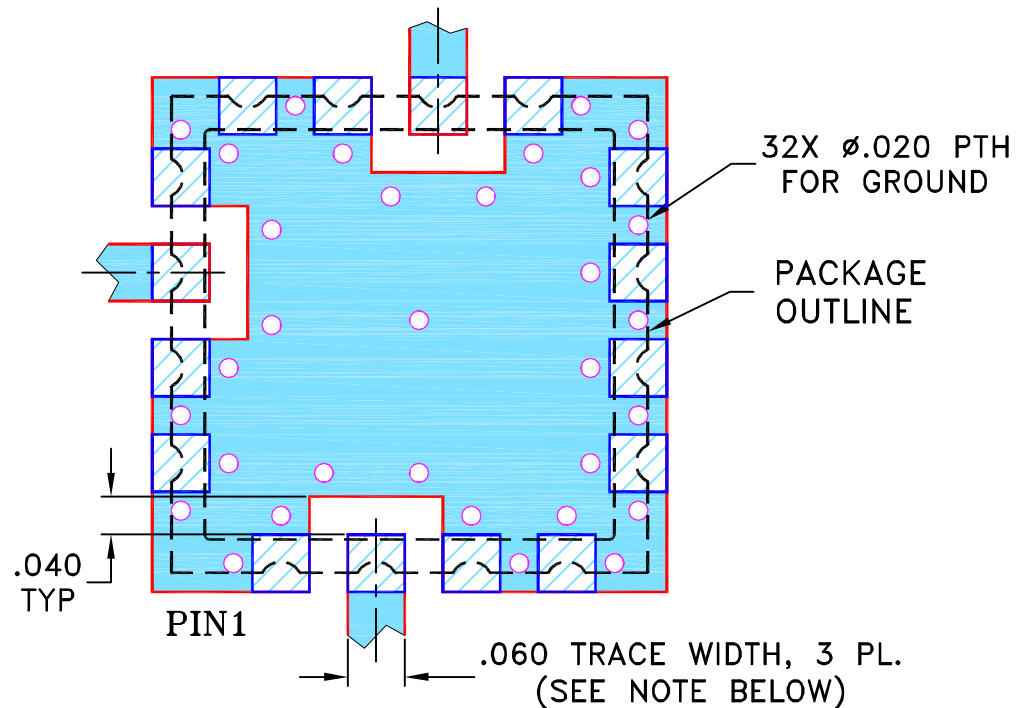

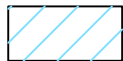

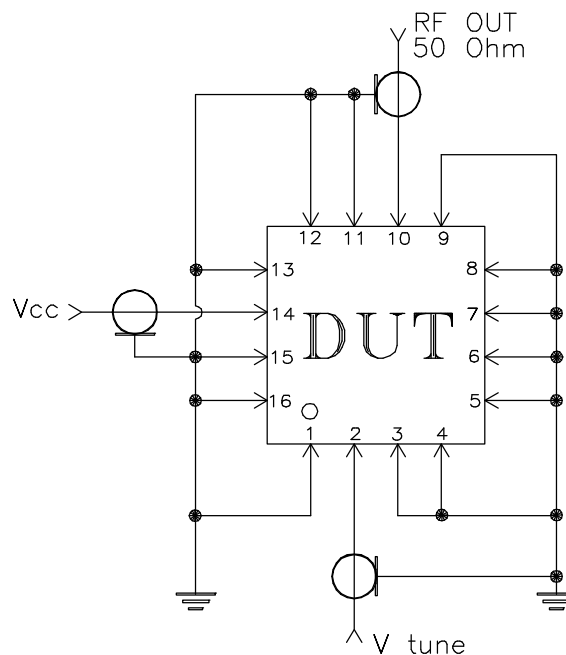
