Typical Performance Curves

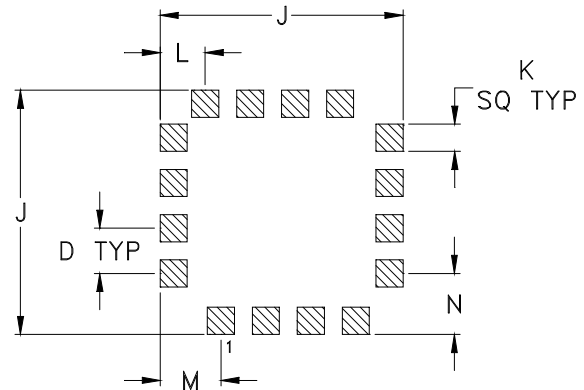
