Typical Performance Curves

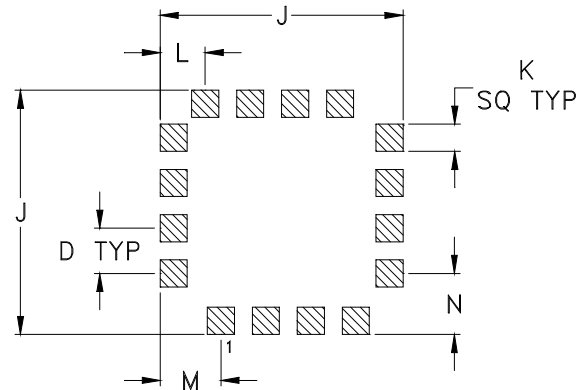
