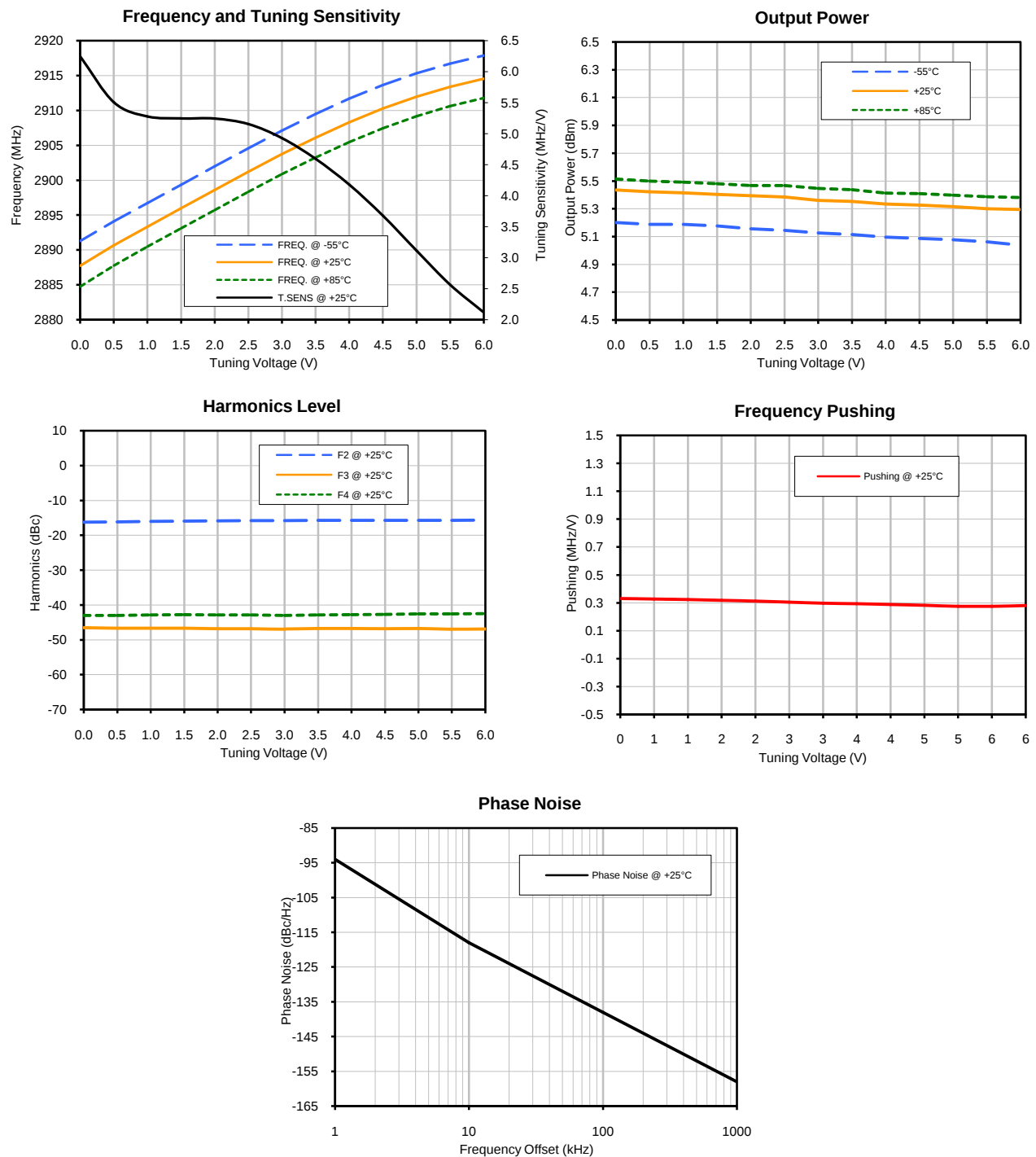

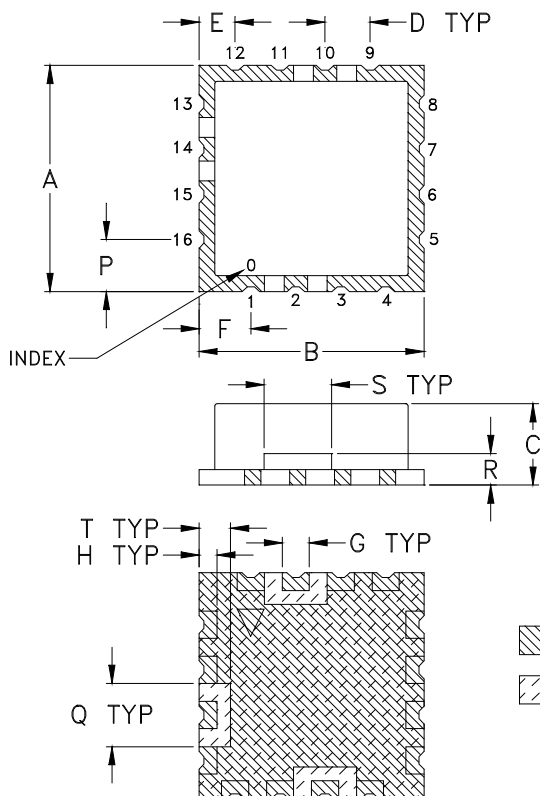

Typical Performance Curves

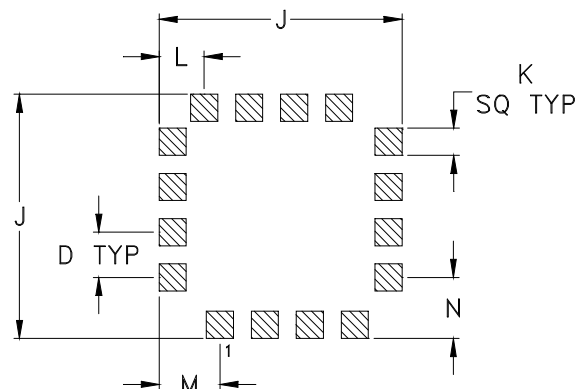
