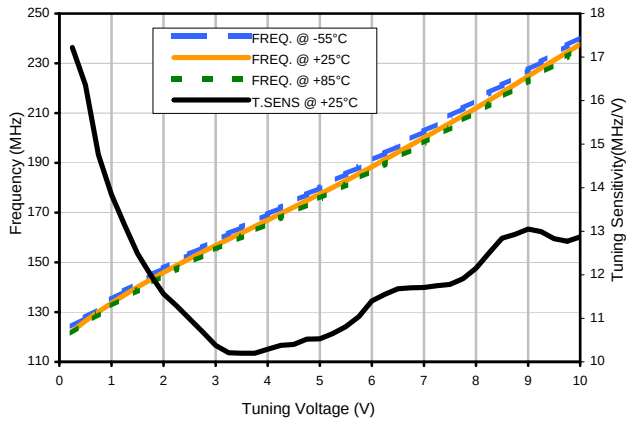

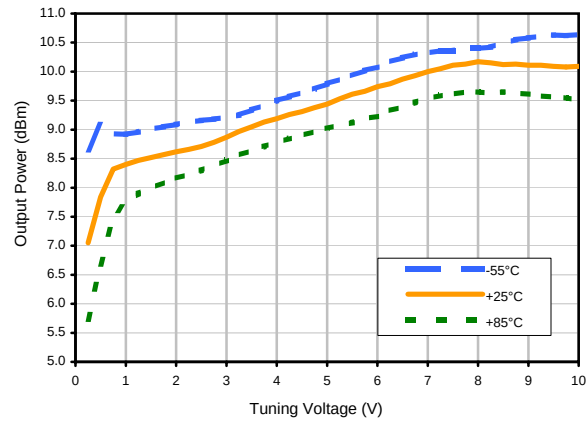

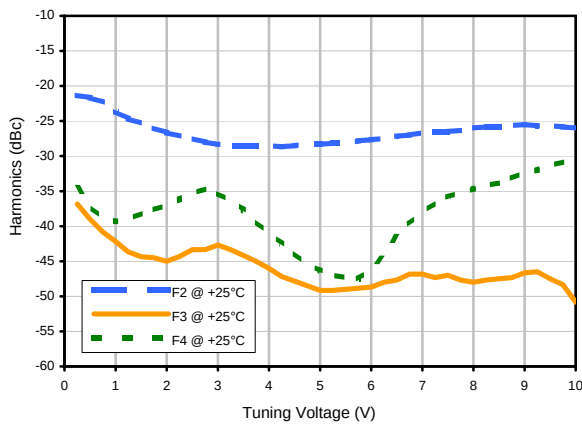
Frequency and Tuning Sensitivity



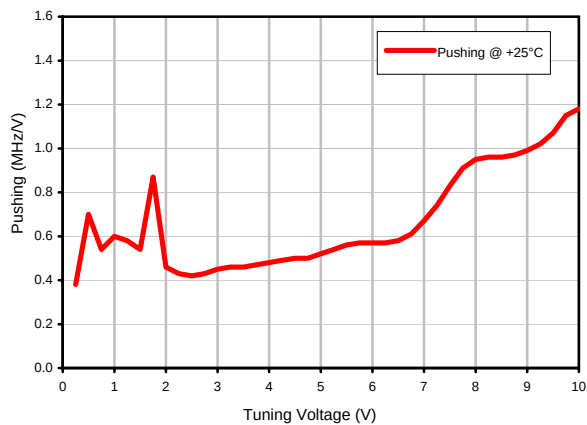
Power Output



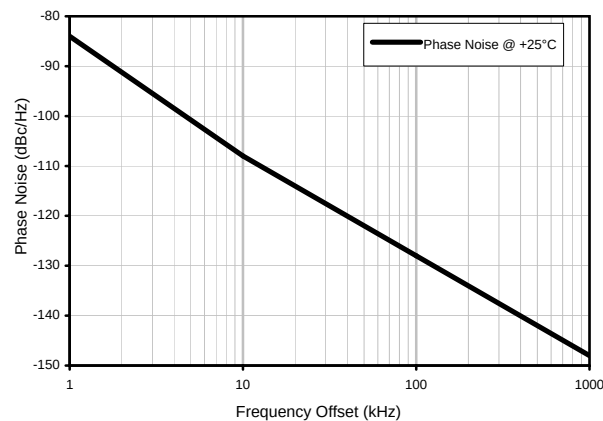
Harmonics Level



Frequency Pushing



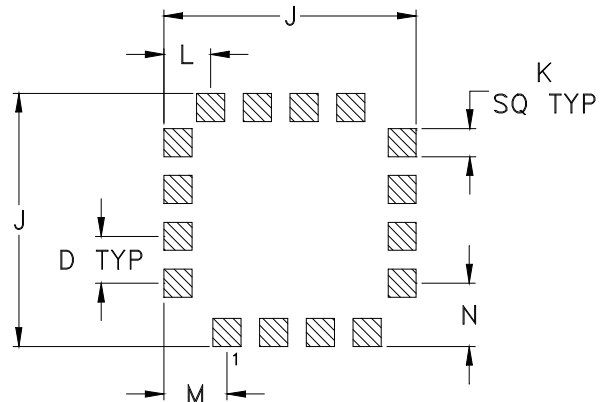
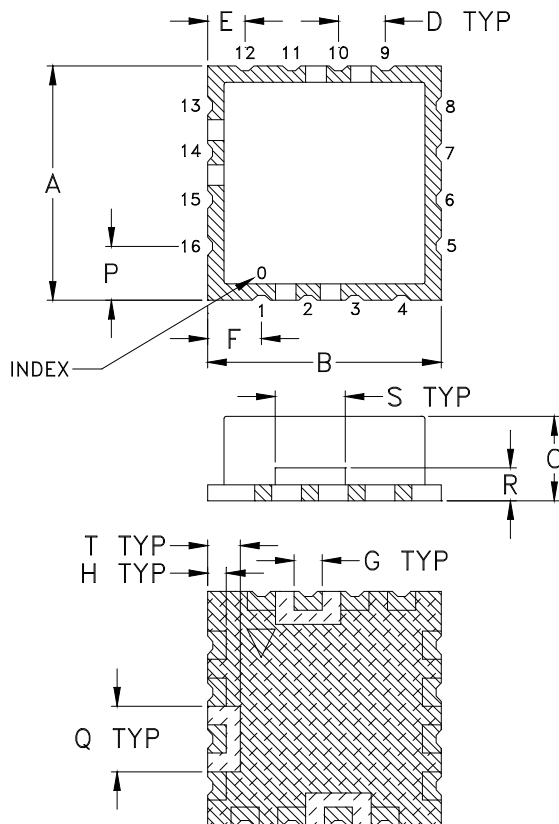

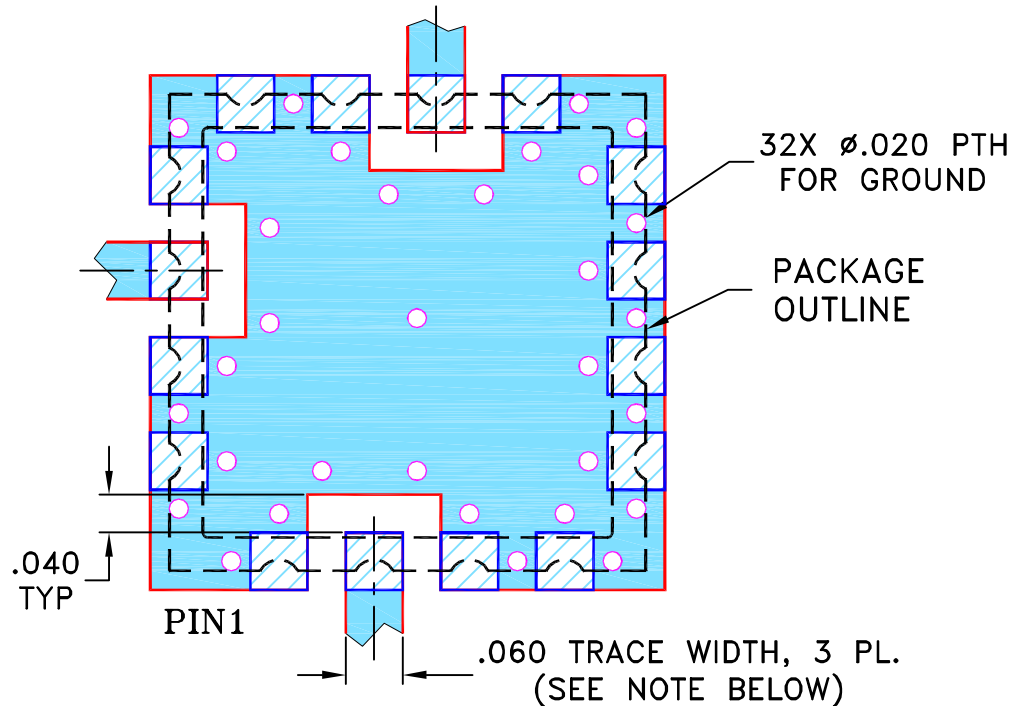

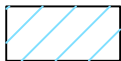

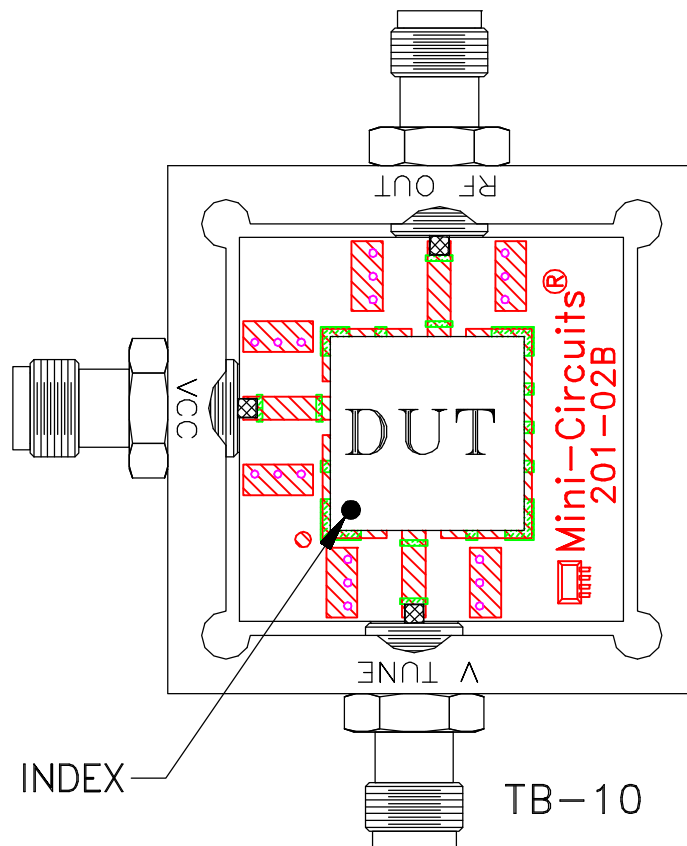
