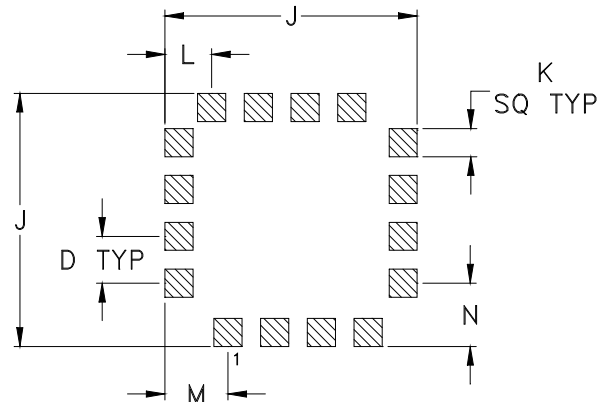
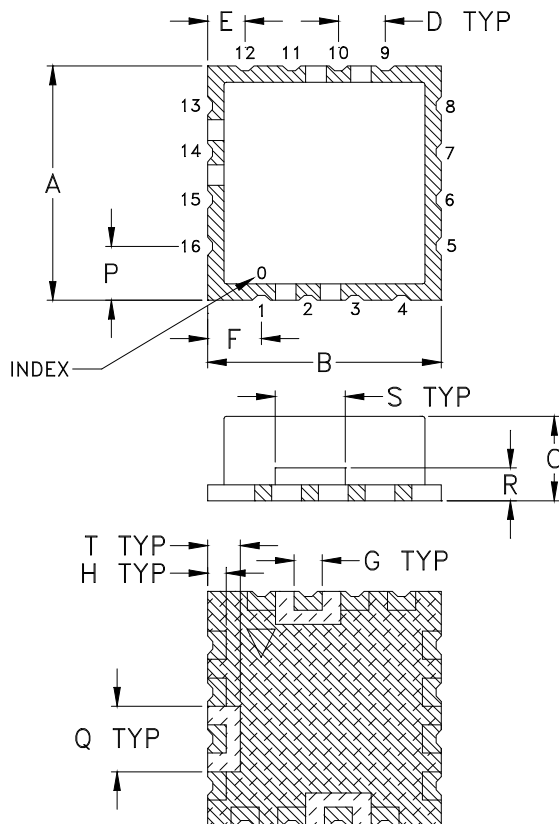
Typical Performance Curves

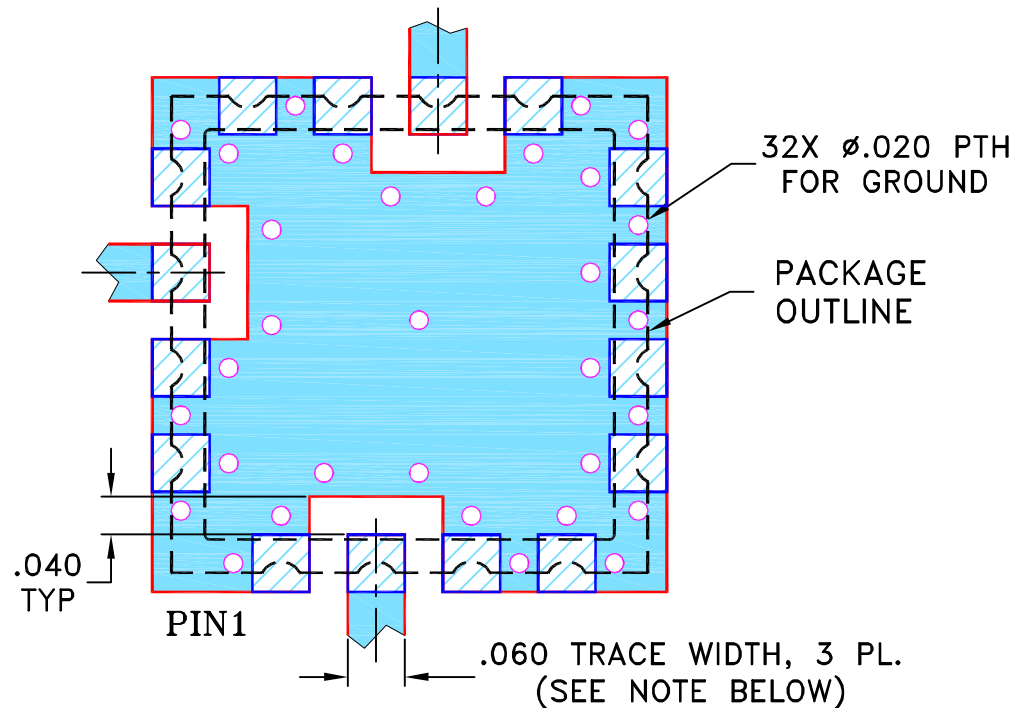

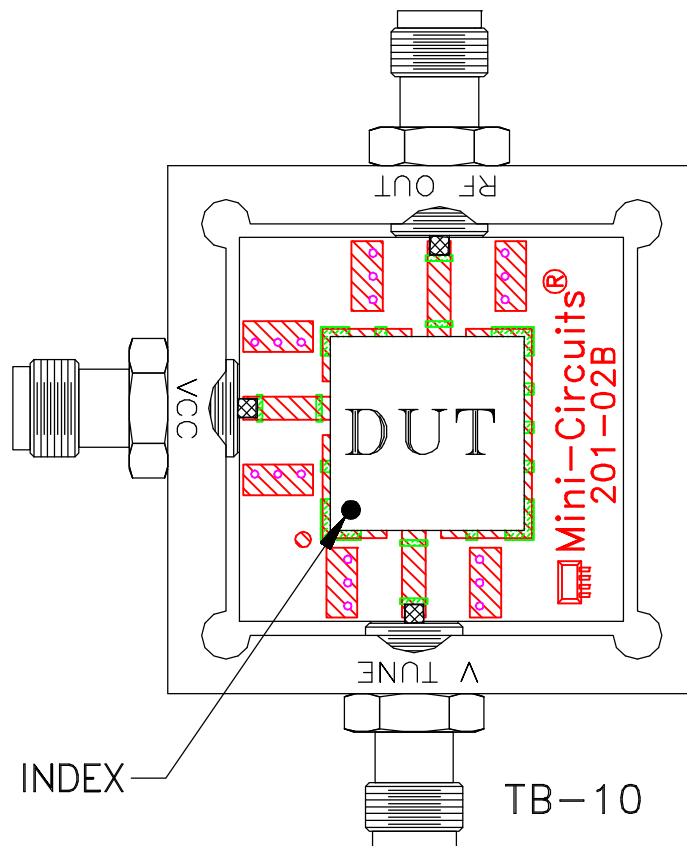
