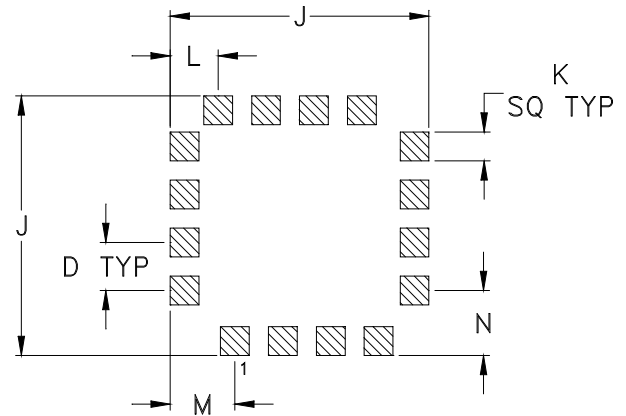

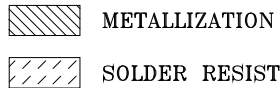
Outline Dimensions

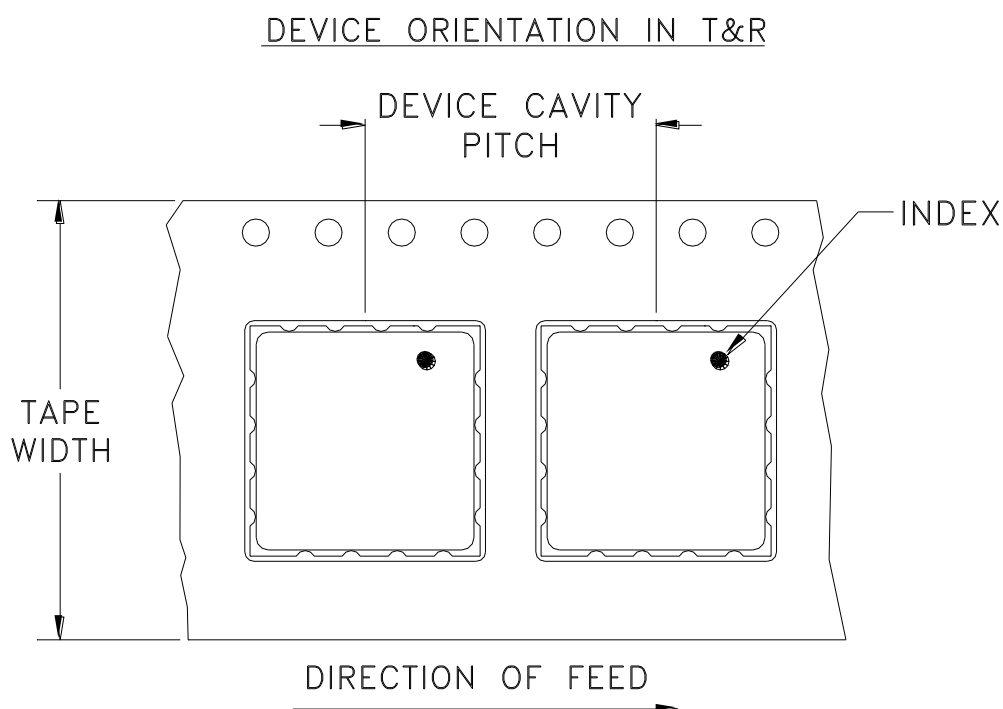
