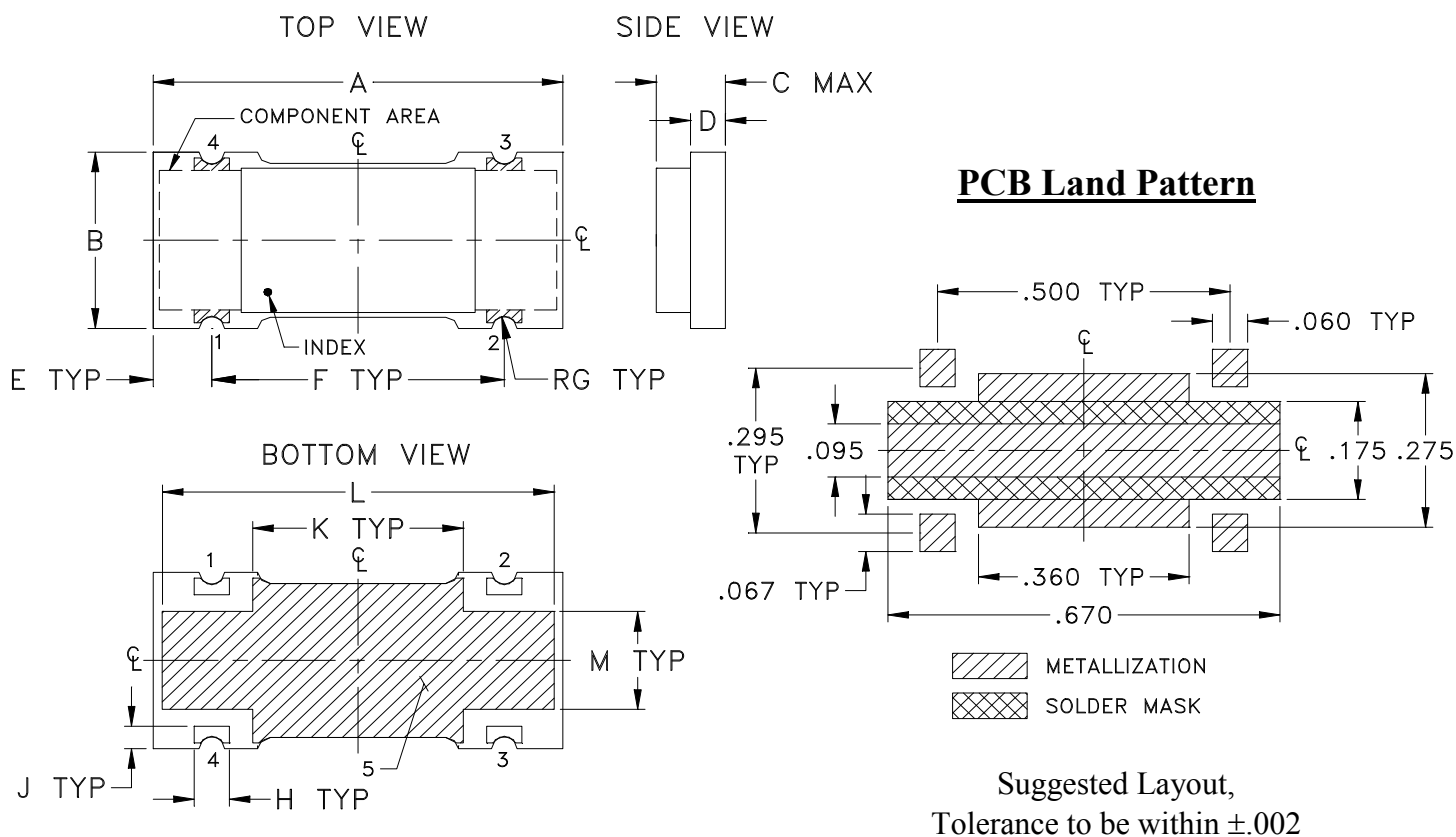

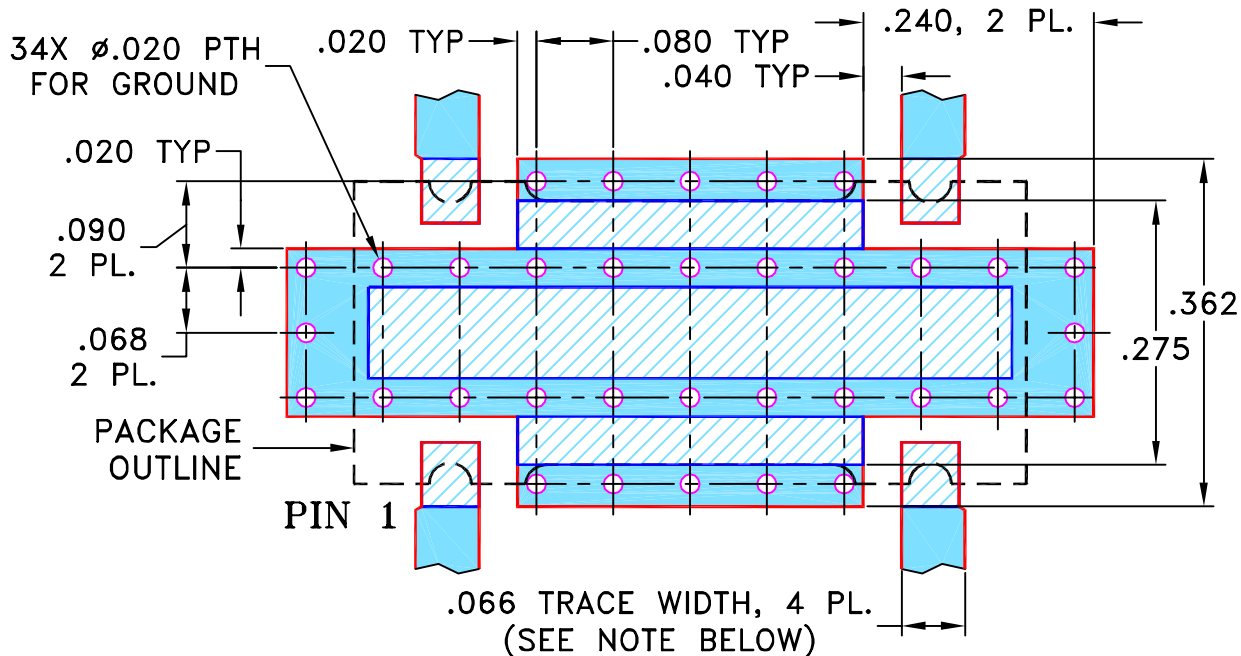
THIRD ANGLE PROJECTION



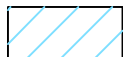

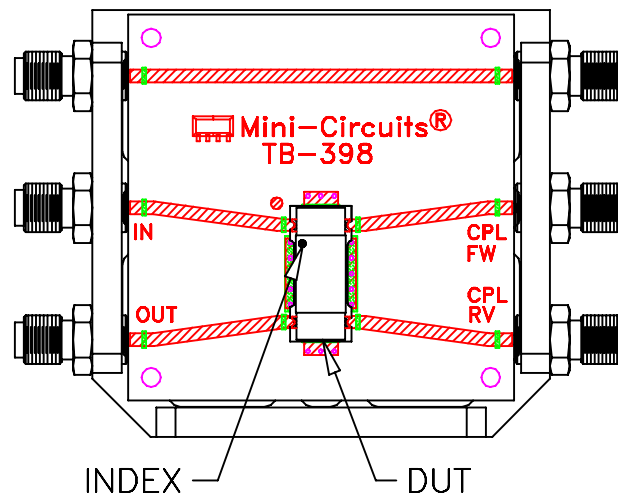

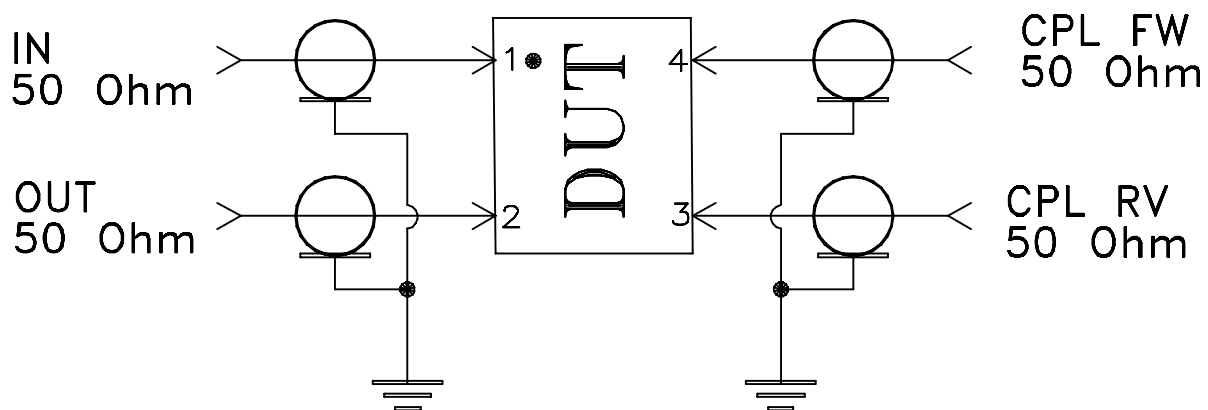
