

FOR DG983-1 CASE STYLE, qp PIN CONNECTIONS, 75 Ω.



- 1. TRACE WIDTH IS SHOWN FOR FR4 WITH DIELECTRIC THICKNESS. .025"±.002". COPPER: 1/2 OZ. EACH SIDE. FOR OTHER MATERIALS TRACE WIDTH MAY NEED TO BE MODIFIED.
- 2. 0603, 0402 SIZES CHIP FOOT PRINTS SHOWN FOR REFERENCE, VALUES OF RESISTORS WILL VARY BASED ON APPLICATION.
- 3. BOTTOM SIDE OF THE PCB IS CONTINUOUS GROUND PLANE.
